Learning in Retirement will host a community health conference on Friday, April 23, 2010, titled, “Living Healthy in Retirement”. The conference will be held at Capitol Plaza Hotel from 9:00 a.m. to 3:00 p.m. with registration and exhibits opening at 8:00 a.m. The conference is open to the public.

**"We're Off to See the Wizard"**

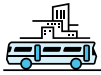
*Saturday, April 17, 2010*

**TRIPS** FEBRUARY- JULY 2010**Springtime in Iowa***Tuesday - Thursday, May 4-6, 2010*

Destination—East Central Iowa!!! We will visit two national historic landmarks, the Herbert Hoover Presidential Museum in West Branch and the Amana Colonies. Then traveling a bit south to Kalona, we will have the opportunity to learn more about the simple life of an Amish settlement.



After boarding the coach on Tuesday with departure at 7:30 a.m., our first rest stop will be in Palmyra and then lunch in Mount Pleasant, Iowa. The afternoon will find us touring the Herbert Hoover Museum and National Historic Site. In the galleries you will experience the many sides of Iowa's only president. Few Americans have known greater acclaim or more bitter criticism. The outdoor tour with guide includes Hoover's birthplace, his grave site and the Friends Meeting House. You will find this museum both educational and entertaining!

Our 'home away from home' will be the Country Inn and Suites in Coralville. After we check in we will have dinner at near-by 'Old Country Buffet' (included with registration fee).

After Wednesday's breakfast at the motel, we will travel to the Amana Colonies, America's longest lived communal society. Six villages were established here in 1855 with men and women assigned jobs by their village council. In 1932 a profit sharing corporation was formed. Today the colonies represent an American dream come true, a thriving community founded on religious faith and community spirit. We will view a short video at the Heritage Museum followed by a drive through the villages with narratives by our own step-on guide. There will be stops at an operating country store, the community church and the communal kitchen. Lunch will be at the Ronneburg Restaurant (included). Following lunch there will be time for browsing or shopping before a performance at the Old Creamery Theatre titled "Everyone Loves Opal". After the play, dinner will be on your own; several restaurants are within walking distance of the motel.

Thursday we will travel to Kalona, home of the largest Old Order Amish settlement west of the Mississippi. We will have an up-close look at an Amish community of

German speaking descendants of Iowa settlers of more than 150 years ago. We'll visit the Kalona Historical Village, see a cheese making demonstration and a display of old and new quilts, ending with lunch at a conservative Amish home, a treat we will surely enjoy!

With new insights into a way of life different from our own, we will head home.

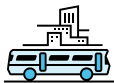

**The Law and Our Court System**

**Week 2** (Trials 1): (a) How are trials initiated and carried out in Missouri's adversary system? (b) What roles do prosecuting attorneys and plaintiff attorneys play in our legal system?

**Week 3** (Trials 2): (a) What roles do defense attorneys play in our legal system? How effectively are defendants guaranteed legal representation in Missouri? (b) What roles do judges and juries play in Missouri's courts? What powers do they have, and what limits are placed upon their powers?

**Week 4** (Other Courts): (a) Why does Cole County have special courts for juveniles? How do the juvenile courts work? (b) What appellate courts do we have in Missouri? What is the function of the state's appellate courts? How may citizens play an informed role in the selection of Missouri's judges?
