# This is our year to celebrate!



For the past 25 years, Learning in Retirement has provided a unique niche in our community that offers educational opportunities for seniors. The inception of institutes for learning in retirement was fueled by the growth of Elderhostel's working with schools of higher education, such as Lincoln University, to provide community based programs for seniors. Because of the desire of Dr. Gary Scott, who was LU's Dean of Graduate Studies and Continuing Education, this type of institute within the Jefferson City area would become a reality. By 1992, the LU Institute would be the first in Missouri.

Just like a small flame that requires oxygen to grow, the institute idea grew within our community due to those individuals that came forward and offered their support. Sixty-five members joined the first year. During subsequent years membership grew, LU-LIR took over full management of the LIR Institute and registered as a not-for-profit corporation. Volunteers continued to step forward over the years to accept leadership positions on the Board, committee chairmanships and became active committee members that helped foster the growth and appeal of the organization.

LIR has experienced substantial growth throughout the past two and a half decades, with a membership reaching near 400 individuals. The continued addition of new interest clubs, a wide-array of courses and a variety of travel opportunities has added to member participation. Our organization should be proud that we are able to provide continuing learning opportunities and promote the sharing of ideas, knowledge and experience for retirees and seniors in Jefferson City and the surrounding area. I know that we can all say,

#### Constitution/By-Laws Revisions

The following two proposed revisions will be presented and voted on at the membership meeting on January 18, 2017.

# **RE:** Constitution revision – LIR Executive Committee nomination/election timeline

Article V – Organization and Offices

Paragraph 7: The Nominating Committees' recommendations for the Executive Committee and if necessary, the President's recommendation for an unfilled position, are presented to the Board and a vote cast at the (May) August Board meeting. Incoming officers assume their official duties on January 1<sup>st</sup> and serve until December 31<sup>st</sup>, of the coming year. (Change May to August).

RATIONALE: The timeline for the nomination/election of a Board member to the following year's LIR Executive Committee is not in alignment with the summer semi-annual meeting. The Executive Committee (officers) is elected from the membership of the Board. We cannot elect a Board member who is finishing his/her first 3-year term to an office until he/she has been elected to serve their second 3-year term that occurs at the summer semi-annual meeting. Therefore, it is recommended that the nominating and election of LIR Executive Committee (officers) by the Board not take place until the August Board meeting that follows the semi-annual meeting.

# RE: Constitution revision-LIR Committee chair appointments

Article VIII - Committees

Paragraph 1: The President shall appoint all Committee chairpersons. Committee Chairpersons shall serve one-year terms, and shall be eligible for reappointment. ADD: Chairpersons may serve up to six (6) one year terms.

RATIONALE: The six-year term mirrors the same length of time that an elected Board member may serve (two three-year terms). It will also provide an opportunity for more members to serve in committee "leadership" positions. Vice-chairman will be able to closely work with chairman during this time period and be considered for chairmanship of the committee when available.

# Kansas City Union Station, Pompeii Exhibit and The Roasterie

Tuesday, March 21, 2017

Join LIR for a day trip to Kansas City Union Station for the Tour of Pompeii: The Exhibition, a date with a Harvey girl to learn about Union Station's history, and then on to The Roasterie, one of the nation's most renowned specialty coffee roasters, to learn about coffee from beans to brew.

Union Station is our first destination, beginning with the Tour of Pompeii. The exhibition examines the lives of the doomed residents both before and after the massive eruption of Mount Vesuvius in 79 A.D. Guests will relive the eruption through a 4D theatre before stepping into the gallery to view over 200 artifacts.

After an included lunch at the iconic Harvey's in Union Station, a "Harvey Girl" will take us through the history of the building, beginning with its 1914 opening through a gangster massacre, two world wars, and more.

Our final stop will be The Roasterie to learn about direct-trade coffee, roasting and brewing, including a tasting, and time in their gift shop.

# St. Joseph, MO: New & Old

Tuesday, Wednesday, Thursday, May 23-25, 2017

Come travel to Missouri's first and last frontier located on the scenic river bluffs overlooking the Missouri River. St. Joseph is a contemporary city blended with more than 150 years of history – creating a city of contrasts and character you will never forget.

While in St. Joseph on Day 1, we will visit the **Glore Psychiatric Museum** housed on the grounds of the old State Lunatic Asylum #2. You will be fascinated by 400 years of psychiatric treatment and the history of this impressive facility. At the **Mt. Mora Cemetery**, you will see the resting places of three Missouri governors, three generals, a Pony Express rider and an English Knight.

Day 2 will be a busy one. We will open the day on the campus of Missouri Western State University to tour the **Walter Cronkite Memorial**, dedicated to the life of one of St. Joseph's greatest native sons and designed to honor the legendary CBS News anchor. We will also visit the **Bushman Planetarium** and tour the **Indoor Sports Complex (Chiefs Training Camp)**.

After lunch at Galvin's Dinner House, we will take a step back in time. At the **Patee House Museum/Jesse James Home, Pony Express Museum,** and the **Robidoux Row Museum,** we will see the head-quarters for the Pony Express in 1860 and the finest hotel west of the Mississippi. We will hear about the creation, running, and demise of the Pony Express and see the circa 1840s housing units that met the housing needs of westward-bound pioneers.



Yet, that very same century turned into a time of unprecedented brutality and devastation in many places. It has also been called "The Century of Total War." We learned that we belong to a species that could do amazing, positive things to make the world a better place. At the same time, we also learned that we could use our intellectual and technological powers to bring about destruction that could—and did—destroy the lives of incredible numbers of men, women, and children.

The wars affected people of all sorts, including serious composers of music. This class will explore how the wars affected classical composers personally and how they responded in their music.

The course will be divided into two sections, with the first section devoted to "The Great War" (World War I) and the second section devoted to World War II. In each section, we will listen briefly to examples of the patriotic music that was used to stir people to support their countries' war efforts, followed much more fully by examples of music that show the reactions of composers to the tragedies of the wars, which many of the composers experienced directly.

Out of the ugliness of the wars came the inspiration for the creation of music we can experience to probe what it means to be human.

Week 1: DNA Casework and CODIS


The DNA Casework section examines evidence for body fluids and for comparison to the profiles of individuals associated with the crime. The CODIS section processes samples from individuals obligated by statute to provide a DNA sample.

- Week 2: Latent Prints and Trace Evidence

  The latent print section locates, processes, and preserves friction ridge impressions and determines whether two friction ridge impressions originated from the same source.

  The trace evidence section tests hair, fiber, paint, glass, explosives, and fire debris.
- Week 3: Drug Chemistry and Toxicology
  This section covers conducting chemical
  analysis of evidence confiscated during
  criminal investigations involving dangerous drugs and clandestine labs.
- Week 4: Firearms and Toolmarks
  This class examines evidence related to
  firearms, firearm components, ammunition,
  tools, toolmarks, footwear, and tire tread
  impressions.


